We are pleased to invite you to the 2nd EURASTiP thematic Brokerage Event which will be a guided program for maximising business opportunities between south-east Asian and European aquaculture stakeholders.

This trade mission will take you on site visits to companies along the aquaculture value chain within the Mekong Delta (Vietnam) and Chachoengsao & Chanthaburi (Thailand). The event includes participation at an invitation-only SUSV-EURASTIP brokerage event in conjunction with Vietfish (the Vietnam Fisheries International Exhibition which has become the number-one professional fisheries showplace in Asia), as well as a parallel EURASTIP brokerage session in Thailand. In addition, the event offers the opportunity to discuss and meet with an invited delegation of aquaculture stakeholders from Bangladesh.

Under the European Union Horizon 2020 Framework, funding is being made available to selected industry sector delegates for reimbursement of travel & subsistence costs.

Tuesday 27- Wednesday 28 August	Site visits Mekong Delta: e.g. hatchery, grow out and processing plants of pangasius, Asian seabass and shrimp, mud crab hatchery, artemia culture. Upon interest and request.
Thursday 29 August	Travel back to HCMC + visit Vietfish
Friday 30 August	EURASTIP Thematic Brokerage Event "EU-Vietnam dialogue"
Saturday 31 August-Sunday 1 September	Site visit + time for business/tourism + travel to Bangkok (Thailand)
Monday 2 September	EURASTIP Thematic Brokerage Event "EU-Thailand dialogue" in Bangkok (Thailand)
Tuesday 3- Wednesday 4 September	Site visits Chachoengsao and Chantaburi: e.g. hatchery, grow out and processing plants of tilapia and shrimp, integrated shrimp/tilapia/Caulerpa farm, artemia culture, swimming crab. Upon interest and request.
